Greetings from the **Indian Institute of Technology Kanpur!**

I am reaching out to you on behalf of the Director, Indian Institute of Technology Kanpur, aiming to extend a formal invitation and provide detailed information regarding an upcoming event. IIT Kanpur has designed a 5-day residential leadership development programme coined the 'Nurturing Future Leadership Programme', which is scheduled to take place from March 27 to 31, 2025, under the guidelines of the Malaviya Mission Teacher Training Programme (MMTTP), Ministry of Education. This programme aims to cater to permanent faculty members in centrally funded institutes with a minimum of three years of teaching experience. The programme promises to be a transformative experience, contributing significantly to the professional development of your faculty members.

Considering the aforementioned, we earnestly invite your esteemed institution to actively engage by nominating at least **two eligible permanent faculty members** for this leadership development programme. Registration is open for thirty participants, with some leeway to accommodate a slightly larger group if necessary, and nominations are due by **10th March 2025**, or until each of the seats has been occupied in advance, whichever occurs first.

The course fee per participant is Rs. 50,000/- (inclusive of food and boarding charges for 5 days), which would be **paid by the Ministry of Education (MoE) under the Malaviya Mission Teacher Training Programme (MMTTP) scheme**. This fee encompasses academic charges and study materials, along with boarding and lodging expenses. The cost of travel (to and from the host institution) shall be borne by the participants' institutions. However, participants or their sponsoring institutions are accountable for covering all travel and daily allowance (TA/DA) expenses. In case of more than 2 participants nominated by the institutions, the full cost shall be borne by the participant's institutions for those additional participants.
