Notification

It is hereby notified for the information of all concerned that the Hon'ble Vice-Chancellor, in anticipation of the approval of the competent authority, has approved to the following fee structure for candidates admitted to the Ph.D. Program under the **Foreign National (FN) Category**:

S. No.	Particulars	Fee
1.	Candidates admitted under the Foreign National (FN) Category in the Science & Engineering streams.	US \$ 3,500 (one-time payment, inclusive of tuition fee)
2.	Candidates admitted under the Foreign National (FN) Category in Humanities streams	US \$ 2,700 (one-time payment, inclusive of tuition fee)
3.	Hostel accommodation	US \$ 1,500 Per Year

It is further notified that the following conditions shall govern the payment and administration of the above fees:

1. The breakup of the tuition fee under various fee heads shall be in the same proportion as prescribed for domestic students.
2. The hostel fee shall comprise three components, namely: Hostel Rent (80%), Hostel Welfare Fund (10%), and Hostel Maintenance Fund (10%).
3. In cases where the financial assistance provided by the sponsoring agency is less than the prescribed fee, the candidate shall be required to pay the balance amount.
4. The tuition fee shall cover the prescribed period of residence for the Ph.D. Programme, i.e., three years. In the event that the period of residence is extended beyond three years, an additional fee of US \$ 500 shall be payable for each subsequent year.
5. Any request for refund of fee consequent upon cancellation of admission shall be submitted within three months from the date of admission. Subject to the applicable rules, a maximum of 80% of the fee shall be refundable. No claim for refund shall be entertained after the expiry of the stipulated period.
6. In the case of sponsored candidates, any request for cancellation of admission shall be submitted by the sponsoring/funding agency. Any refund of fees, if admissible, shall be remitted to the sponsoring/funding agency only.
7. The tuition fee, hostel fee, and any other applicable charges payable by sponsored candidates shall be governed by the fee structure approved by the sponsoring agency and/or the University, as applicable, and shall be subject to revision from time to time in accordance with the prevailing rules and decisions of the sponsoring agency and the University.
