It is notified for information of all the concerned that the Vice-Chancellor, in anticipation of the approval of the competent body, has authorized implementation of the following Policy for admissions under NRI/NRI Sponsored quota:

1.	Seat Allocation	A maximum of 10% of the intake capacity shall be offered over and above the sanctioned intake.
2	Eligibility & Admission Criteria	Admission shall be based on merit determined from qualifying examination
3	Fee Structure	Double the Self-Financed Fee in addition to the regular program fee.
4	Mode of Payment	<ul> <li>For Programs up to 2 Years</li> <li>50% of the NRI fee at the time of admission to 1st Semester</li> <li>25% at the time of promotion to 3rd Semester</li> <li>25% at the time of promotion to final Semester</li> <li>For Programs of 4 Years or more</li> <li>NRI fee to be paid in four equal instalments (25% each) at the time of admission/promotion to the 1st, 3rd, 5th, and 7th Semester.</li> <li>Normal Program fee to be paid as per the prescribed University.</li> </ul>
