It is notified for the information of all concerned, that the University Syndicate at its meeting held on 27-09-2025 has approved the following recommendations of the constituted Committee for Bachelors Degree Programme offered by the Shri Pran Kishan Koul Institute of Music and Fine Arts (SPKK-IMFA):-

1. that henceforth all the internal examinations (theory and practical) for 1st to 3rd year shall be conducted by the Controller of Examinations on the same analogy as is done by the Controller of Examinations for 4th year of the programmes and shall also maintain

all the data related to conduct of examinations and declaration of results.

2. that awards of all the existing batches i.e. 2021-2025 shall be forwarded to Automation Unit of Examination Section by Shri Pran Kishan Koul Institute of Music and Fine Arts (SPKK-IMFA) to ensure updation of complete data of the students. The Principal

of the Institute shall henceforth submit E-award.

3. that the Controller of Examinations shall henceforth issue marks sheets in favour of Shri Pran Kishan Koul Institute of Music and Fine Arts (SPKK-IMFA) students as per practice in vogue in other affiliated colleges and same analogy shall be implemented for all previous batches for which Shri Pran Kishan Koul Institute of Music and Fine Arts (SPKK-IMFA) shall submit data to Controller of Examinations batch wise.

4. that the Examinations Wing shall be responsible for issuance of stationary etc. for conduct of examinations for the programmes offered by the Shri Pran Kishan Koul

Institute of Music and Fine Arts (SPKK-IMFA).

5. that the staff members of Shri Pran Kishan Koul Institute of Music and Fine Arts (SPKK-IMFA) shall be entitled for same honorarium as is being paid in favour of the other staff members for conduct of examinations, paper setting and evaluation. Furthermore, the Principal will be the Chief Observer for the said examinations.
